

Definitions

Directed Trust—There is language within the trust document that names the corporate trustee and directs all investment activity and authority to a direction advisor (separate from the trustee). The trust document includes indemnification language that relieves the trustee of any investment authority or investment oversight. This type of trust requires the advisor or third party to be able to take on all investment oversight and authority without any oversight by the trustee.

Delegated or Discretionary Trusts—The corporate trustee has the investment oversight and investment responsibility but can delegate the investment activity to an outside advisor. This is often the case in existing trust documents that do not contain the indemnification and bifurcation language of a directed trust or in cases where the advisor is required to have investment oversight by the trustee.
